6:00 P.M. Local Law Introductory "A" of 2019

Stop Sign on Liberty Ave

The Town Supervisor then opened the Public Hearing at 6:01 P.M., in the matter of Local Law Introductory "A" of 2019. [The Town Clerk had available copies of the proposed local law, the Notice of Public Hearing, Affidavit of Posting, Proof of Publication in The Observer Dispatch.]

Councilman Lenart informed the Board that there was a petition put forth by local residents for stop signs to be placed upon the intersection of Liberty Ave and Coxe Ave, he also mentioned that Police Chief Inserra had also given his agreement that stop signs were warranted in the area.

<u>Ed Wickham, 16 Liberty Ave</u> - There are a lot of children in the area, a lot of motorists use the street as a "cut-through" to avoid longer routes. Mr. Wickham was also looking for a speed reduction but was told without a School on that road that there would be no reduction. His main concern is the children and making their safety a priority.

<u>Sharon Colon, 14 Liberty Ave</u> (Corner of Liberty Ave and Coxe Ave)- Cars turn down Liberty Ave from Middle Settlement as a way of a "short cut", motorists "fly down that road, putting a stop sign there, at least they would have to come to a *hopefully* complete stop, and they are slowed down by the time they go by the houses with the kids."

There being no one further to speak in the matter, the Public Hearing was declared closed at 6:03P.M.

Councilman Woodland requested that the Chief of Police follow up with stop sign enforcement once the stop signs are put up, if the Local Law is approved.

Supersede the Whitehall Doctrine

The Town Supervisor then opened the Public Hearing at 6:04 P.M., in the matter of Local Law Introductory "B" of 2019. [The Town Clerk had available copies of the proposed local law, the Notice of Public Hearing, Affidavit of Posting, Proof of Publication in The Observer Dispatch.]

The proposed Local Law would supersede the common law Whitehall Doctrine and Doctrine of Incompatibility.

Whitehall Doctrine: Pursuant to the common law doctrine established in Wood vs Town of Whitehall, it is the general rule that a body having the power of appointment may not appoint one of its own members in the absence of precise statutory authority so to do.

Doctrine of Incompatibility: The common law doctrine of incompatibility declares to be incompatible any two public offices which there exists and inconsistency of function or where the basic duties of each office would necessarily interfere with the other, or where the holder of one would be required to account or to be subordinate in some way to the other.

<u>Jim Lawrence, 67 Imperial Drive</u> – Questions Supervisor Miscione as to whether he had received an opinion letter back from the Attorney General. Supervisor Miscione responded that they had only received correspondence so far, it was advised that the Town Attorney is to write a letter to the Attorney General to get a formal opinion on the Town's unique situation.

There being no one further to speak in the matter, the Public Hearing was declared closed at 6:08 P.M.

The Town Supervisor declared the Resolution unanimously carried and duly ADOPTED.

Presentations and Comments from the Public:

<u>Kari Procopio, 30 Balsam Crescent</u> – Mrs. Procopio questions the "rule" about posting the agendas for Town Board meetings (or any other meetings) because residents who want to know in advance, or there may be an issue on the agenda and they may want to attend. It just seems that the agenda only goes up the day of the meeting. Supervisor Miscione explained that to avoid residents getting "cut off" the agenda, as a courtesy to the residents, the Town leaves the agenda unposted until the day of so everyone could get items on to avoid waiting sometimes weeks to a month. Mrs. Procopio continued that as a busy, working-mom herself, along with other town residents, having a "heads-up" in advance would "help keep open communication with the residents so they know what's going on and what to expect at the next board meeting."

Mrs. Procopio also requested clarification about statements made at the last board meeting (January 24, 2019) and as to why the purchase of the adjacent land was not included in the original sale of the property the Town currently owns. The Town Attorney answers that it was owned by a separate entity, at the time of the initial project involving the new Town Hall, the building was more than adequate to house all the Town offices, and that is why the Town went forward. Supervisor Miscione further clarified that the owner of the adjacent land at the time was not interested in selling the land, the Board requested to see if the owner was interested in selling after the purchase of the "Gander Lot" had been made.

Mrs. Procopio then sought explanation as to why Supervisor Miscione had abstained from voting on the land acquisition. Supervisor Miscione replied that he abstained from the deal for the future, if he personally had to "do a deal" with the land owner that there was no scrutiny. He further clarified that he didn't *have* to abstain from voting, he thought it was the "right thing to do"; he also negotiated the deal and "any deal I negotiate I don't vote on".

Councilman Woodland then expressed concerns about mitigation fees, information has "come to light" that the owner of the adjacent land allegedly has not paid mitigation fees from past projects. The Town Attorney would investigate the matter. Councilman Woodland motioned to rescind the prior motion related to the acquisition of the additional land, by stating an investigation is needed going forward. Councilman Reynolds does not believe rescinding the motion is necessary, the accusation "needs to be looked into either way". Councilman Lenart agrees with Councilman Reynolds, "we have the deal, lets get everything squared away first". Councilman Reynolds sees this matter as two separate issues. The motion died as there was no second.

Public Comments Continued:

Jim Lawrence: Referring to a prior email sent to the Town Board, brought up on the subject of the purchase of additional land; "several issues that really aren't up to standard, such as a preliminary value... and IRS exemption ,... you really need a self-contained MAI appraisal". Attorney Cully agreed. Mr. Lawrence also mentioned "serious issues of mitigation forgiveness or credit" and questions what the Town needs to provide the current owner, with regard to the IRS contribution. Attorney Cully states that there is no current agreement, those would be details that would have to be included. Mr. Lawrence continues that when a municipality buys property, they would need to declare a specific purpose. This concluded Mr. Lawrence's public comment period.

Codes Enforcement Officer Joseph Booth introduced Assistant Codes Officer Larry Gell to the Town Board. Warm welcomes were given.

Fireworks Event, July 5, 2019

Supervisor Miscione opened the following discussion "Our fireworks event, last year in our budget we put at Sherrillbrook Park, we said that we would do it on July 5th. In your packets at

your desks here, we put in a proposal from the Genesis Group. They run the fireworks celebrations in Utica, they put everything together, they run the whole organization. I gave you that to take a look at, in the next meeting I'd like to see if you guys want to do that we can approve for them to do it. The fireworks are in our budget, as you know at our last meeting on January 24th we went out to bid – Gail did you put that out yet? "The Town Clerk responded "Not yet, Hopefully by Friday". Supervisor Miscione continued, "So if we get the bid back from the fireworks and we then will have this to look at, maybe we can make a decision if we want them to run the program at the park for the fireworks"

Attorney Herb Cully then brought up Town Code Chapter 88, Section 88-9 entitled "Alcoholic Beverages" that states;

"Alcoholic beverages of any type are not allowed within the Park at any time." Other municipalities in New York State have Town Codes that allow their Town Boards to issue permits on a case by case basis, those Town Boards ensure that applicants are duly licensed by the New York State Liquor Authority to permit the sale of alcohol. Attorney Cully has begun to draft a Local Law that would amend Town's Code which would allow the Town Board, upon receiving sufficient application and proof of compliance with all licensing from the New York State Liquor Authority, the sale of alcoholic beverages. Councilman Woodland questioned if this proposed Local Law would be similar to Local Law No. 4 that was passed in 2018 allowing Food Truck Vendors in Sherrillbrook Park, which was then confirmed by Attorney Cully. Supervisor Miscione spoke of additional groups, including Genesis Group and the Central New York Food Fest that have expressed interest in the sale of craft beer and wine in Sherrillbrook Park. The common practice by Genesis Group is to fence off a designated area in which alcoholic beverages are allowed, if a person wished to leave the area than the alcoholic beverage would have to be disposed of. Councilman Messa spoke against this proposed Local Law stating that the Town Board should now allow alcohol in the Parks. Stating that it sends the "wrong message", and there is the potential to "open ourselves up". Councilman Messa also argued that "Our parks have kids in there and it should not be allowed".
