PRESENTATIONS/ COMMENTS

Patricia Todd – 8 Compton Road: Mrs. Todd has given the Town Clerk Gail Wolanin Young a petition that reads as follows:

"These citizens of the Town of New Hartford request that the Town of New Hartford adopt a noise ordinance that includes a specific provision for 'unattended noise'. This is noise generated by a radio or some other mechanical or digital device that is played when no person or persons are present. As with the 'car noise' ordinance, which the Town of New Hartford already has on its books, generated noise that is audible more than 50 feet away should be considered a violation when a citizen complaint is received. Other criteria such as vulgarity can also be considered. However we ask the Town Council to keep the language simple and avoid technical

criteria that makes it incumbent upon citizens or the New Hartford Police Department to acquire and use technical or scientifically calibrated devices to measure the amount of noise."

The petition was signed by 83 residents of different neighborhoods of the Town of New Hartford.

James & Theresa Davis, Judy Virkler – 239 Oxford Road: Mr. & Mrs. Davis along with Ms. Virkler has had some extensive work done at their property by the Town and problems still exist. Photos were distributed to the Town Board to show a pipe that has separation, water can be heard moving through the pipe but the end of the pipe is dry. The family is concerned with safety if anyone were to fall into the hole. Highway Superintendent Sherman responded that the county had replaced about 80-100 ft of 36" diameter piping and that the "leaking joint" was fixed by National Water Main. He also stated that any damage to the driveway would be repaired with asphalt. As for safety the Highway Superintendent said that there was a cover being placed on the end of the pipe on their property.

Jiayue Shen -10 Imperial Drive: She lives across from the Davis-Virlker's and now the opening is at the bottom of a "big slope" she would like to have a fence placed to keep anyone from falling into it. Supervisor Miscione offered to visit the area along with the Highway Superintendent and the Town Engineer, so everyone is able to determine where the impacts are.

Waiver of Retainage Fees - National Grid

National Grid representatives Benjamin Weisel and Patricia O' Kay appeared before the Town Board to give a brief synopsis of the renovation of the existing substation on Woods Road. They are asking for a waiver in regard to the 10% retainage fee, due to the fact it is a renovation, and because they are a public utility, it would cause great hardship if they had to additionally post a retainage.

The existing substation has been operating for 50-60 years and provides power to over 30,000 homes in the area. Engineers from National Grid have determined the transformers on the site are nearing end of their functional life, they will be replacing the existing transformers, a little bit of trenching and replacing instrument transformers. National Grid is preforming this maintenance work all throughout their substations in New York State; they also have an obligation under the New York State Public Service Law to continue to provide safe and reliable electricity for their customers.

Lucille Matt- 3 Hubbardton Road: Mrs. Matt requests clarification of the water retention pond that is scheduled to be placed around Hubbardton Road, Foxcroft Road, and Tibbitts Road area. She also requested the difference between a detention pond and a retention pond. She does not believe a retention pond is aesthetically pleasing and is concerned about standing water and possible insects. Mrs. Matt is also concerned about property values decreasing with the addition of a retention pond. Supervisor Miscione explained that the engineers have selected that location as having the most impact on the flooding of the area. Councilman Reynolds further clarified that it is a "dry basin" and the only time that the area would fill with water was during rain storms, currently the Town is trying to gain access to the general site to take water table benchmarks, surveying and whatever else the Engineers may need.

Ms. Martin – Ms. Martin is interested in doing a zoning law text amendment in the C2 zone to include short term care facility. Ms. Martin's sister is a physician and while they were looking at possible locations to have a short-term care facility it was realized that they would need a zone text amendment. A short-term care facility, by definition is a building or institution that contains offices and dispenses healthcare services that includes related laboratory equipment, including facilities for overnight care of patients for a duration of up to 60 days or less. A site hasn't been selected yet. Councilman Woodland asked what types of services would be rendered at this type of facility. Ms. Martin responded that they were interested in focusing on physical, emotional and mental rehabilitation in a residential retreat type environment.

Update on Projects around the Town

Woodberry Headwall/Wingwall Update – The Town is currently at an impasse, if the Town pays to have the engineering study done, there is no guarantee that New York State will approve of the headwall/wingwall move. Councilman Reynolds said that the whole idea was to move the headwall/wingwall onto FEMA property to avoid going onto a resident's land multiple times a year to clean the entrance of the headwall/wingwall. The Town Board will determine alternate plans, not wishing to obtain an Engineering Report without guarantee that the project will be approved.

Noise Ordinance Petition – Attorney Cully questions the level of enforcement without having a definition of decibel levels. He mentioned that most municipalities "shy away from these types of ordinances". Attorney Cully will get some sample ordinances from the Association of Towns and bring them back to the Town Board. Supervisor Miscione and Police Chief Inserra believes

that this is a dispute between neighbors and the entire town should not be affected, this would just open it up for unfair territory for someone who wishes to bother another person.

9240 Willowvale Ave, Unsafe Building - Councilman Messa questions Codes Enforcement Officer Joseph Booth on if anything has been done with the home on 9240 Willowvale Ave since it was purchased. Codes Enforcement Officer Booth responded that the house is condemned and that he had spoken to the new owner and the plans were to rehabilitate the house. The Codes Department will be sending a letter of compliance to the new homeowner.

2018 Independent Audit

The Town Board members acknowledged receipt of the 2018 Audit performed by Drescher & Malecki LLP. Finance Director Dreimiller provided highlights of the audit:

- At the close of the current fiscal year, the Town's governmental funds, excluding the Capital Projects Fund, reported combined ending fund balances of \$6,916,652, an increase of \$983,934.
- At the end of the current fiscal year, unassigned fund balance for the General Fund was \$2,454,100, or 56.4 percent of total General Fund expenditures. This total amount is available for spending at the Town's discretion and constitutes approximately 95.4 percent of the General Fund's total fund balance of #2,573,209 at December 31, 2018.
- During the year ended December 31, 2018, the total fund balance of the Town's General Fund increased by \$378,153 during the current fiscal year, primarily as a result of higher than anticipated nonproperty tax items.
- During the year ended December 31, 2018, the Police Fund's fund balance increased \$237,081 as a result of savings related to public safety and employee benefits as well as favorable revenues related to nonproperty tax items.
- During the year ended December 31, 2018, the Highway Part-Town Fund's fund balance increased \$215,323 due to overall revenues exceeding the anticipated budget related to nonproperty tax items and sales of property.
- During the year ended December 31, 2018, the Sewer Fund's fund balance increased \$145,291, primarily as a result of less than anticipated contractual expenditures.
- A review of General Fund actual expenditures compared to estimated appropriations in the final budget yields several favorable variances, most notably related to lower than anticipated general government support expenditures. Revenues exceeded the budget primarily due to the receipt of higher than anticipated nonproperty tax items.
- The Town's total primary government net position increased by \$1,857,474 during the year ended December 31, 2018.

- Overall revenues of the Town's primary government increased 15.5 percent from the
 prior year while overall expenses decreased by 8.3 percent. The increase in revenues and
 decrease in expenses are related to the Town receiving reimbursement in the current year
 of expenses incurred in the previous year related to a state of emergency in 2017 for
 flooding
- During the year ended December 31, 2018, the Town's total serial bonds outstanding decreased by \$779,909.
