- **6.** Updated the Bonding Sheets to include the loader for the lease and submitted it to the fiscal advisors; Lease paperwork for the loader total amount for the loader \$92,689, that's with the trade in. Out total payments for the year are \$20,310.43 till 2025.

Zamboni Highway Superintendent Richard Sherman not under state contract, they are not with anybody LSK is out of Virginia Beach, it's an all-electric Zamboni it also has a laser head on it that does things with the ice quote \$173, 410 (Hamilton and Whitesboro have the same model) special charging station comes with it for the battery they had a 2012 model there for repairs and got at least 7-8 years out of it.

Purchase of two (2) sweepers –with Sitcon on Sourcewell – we are a member with them – bought newest equipment from them – so we don't have to go out for bid – they are Johnstown back sweep – two (2) year warranty – 2,000 hours warranty – left side/right side cutter broom – right side gutter tilt if have swales – 8 ½ cubic yard body (stainless steel – lifetime warranty on body) – water tank on board - on the back is a catch basin cleaner – multiple uses – quote is \$275,660 – one for each half of the Town – would replace two sweepers we have – going to keep one for when mill roads and auction other one – Village bought one (bonded for it) – has a rear vision camera – three people going to one - if get the ok tonight will have in March – Zamboni will take one (1) year; Supervisor Miscione – go out to band for it – 30 days to put in paper for two sweepers and Zamboni – re-do band (in Feb) – Zamboni order now to get end of 2021 (takes a year) – so we have for next season – can't order until funding in place – bid Zamboni – sweepers on state contract – put in paper – 30 day notice for band for total of all three

NRCS – Mrs. Martin's Property – Highway Superintendent Richard Sherman – Town Attorney wrote a letter and got a response back dated October 27, 2020 – have given the window of opportunity to open again – numbers the same (\$125,000 estimate) - \$93,750 is allocation and sponsor contributor would be \$31,250 (25%) – someone needs to go out there and make sure the numbers are good for the grant as well as what her sponsorship is going to cost – have 15 days from time letter was given so time is up next Wed. – let them know we are going to proceed then will get the application again, fill it out and move forward; Councilman Messa – has spoken to her and she asked what numbers were; Town Attorney Herbert Cully – does the cost include the engineer; Highway Superintendent Richard Sherman – has to check but believes part of it; Town

Attorney Herbert Cully – they feel that's sufficient to cover everything; Councilman Messa – how do we find out if total correct; Highway Superintendent Richard Sherman – get an engineer out there to look at it; Town Attorney Herbert Cully – I would think would be on her load to assume that responsibility because she's agreeing. We're stuck with that figure. If its going to cost anything more its probably got to come from her. It would be in her interest to have an engineer look at the figures – this reasonable or not, if not, we have to request an amended schedule. If she wants to go with that...but I don't think its incumbent on us to come up with the figure. We're accommodating her by willing to sponsor it with the understanding she's coming up with the access that isn't covered by the grant; Supervisor Miscione – (asked Rick) does that bind us though – we have to make a decision because we don't have enough days to go out to bid and get back to the next meeting so we're going to lose it again – make decision tonight that the determination of the numbers are correct – if any other additional amounts need to be paid, that they paid by her, she can still deny or accept it, but at least we're not loosing the deal. I'd probably wait until they pick somebody for the position and then they can follow up after that and put that person in that spot. We do have that money amount in the budget already plus we have the money for the part timer but again, we don't have what the outcome is going to be. After Councilman Reynolds and Councilman Lenart do the interviews, we will know that. The next Clerk this is appointed should pick that person, who they want to work with; Councilman Messa – will have decision November 21st?; Councilman Reynolds – maybe; Supervisor Miscione – 20th is a Friday – what like to do – we have the 30 day with the band, the solar law, in saying that, if we can pick a day that these things could be done; cancel 11/20/20 and 12/9/2020 meeting – schedule a meeting for December 16, 2020 (last meeting of the year) and then can approve the solar, band, bids for Zambonie, Clerk's office decision, year-end decision – Mel needs to post in the newspaper that canceling meetings and scheduling a new date.
