ORGANIZATIONAL / REGULAR MEETING OF THE TOWN BOARD OF THE TOWN OF NEW HARTFORD, NEW YORK, HELD AT TOWN HALL, 8635 CLINTON STREET, NEW HARTFORD, NY ON WEDNESDAY, JULY 14, 2021 @ 6:00 P.M.

Town Supervisor Miscione called the meeting to order at 6:00 P.M. and led those in attendance in the Pledge of Allegiance to the American Flag. The roll was then taken with the following Town Officials and Department Heads being present during the progress of the meeting.

Thereafter a quorum was declared present for the transaction of business.

I. PRESENTATIONS/COMMENTS

A. Kristen Campbell – Commission for the Sauquoit Creek Basin – discussed flooding and grant opportunities; looking into having Commission meetings at the New Hartford Town Hall; a sentiment and management study was done and will be realized at the July 20th meeting at 4:30pm at the Whitestown Community Center (includes the Town of New Hartford in the study and areas that work can be done.; has allowed to put together grant applications to further modeling in 1. NYM area near Pietryka Park 2. North Side – Main Street (near Highway garage) 3. South Utica/Sunnyside area 4. Victoria Drive – Piggy Pat's area 5. Hand Place area; can work in coordination with area that Town of New Hartford has applied through the GIGP at the Washington Mills Athletic Park; Councilman Reynolds – the settlement and debris mitigation (study hasn't come out yet) that would be dredging areas; Kristen – No, some would be right sizing the creek, putting it back to where it should be, some would be bank stabilization areas, some would be regular maintenance where you would remove some of the settlement deposits. Goal in the end is that the creek works the way it should, have a regular maintenance plan; Councilman Lenart – area between New York Mills bridge and Town Highway garage – is the FEMA; Kristen – think it is going to be a combination (like to get money from modeling and

conceptual design) – FEMA shouldn't have to keep redoing. There are opportunities in that area – there is land there, municipality owned land – like to see something bigger there, not just repair what was done; timeline two to three years; grant opportunities; Whitestown is currently working with CSX and DOT.; John Dunkle – one of the challenges, they fund projects to put back things that were damaged right back to where they were before they were damaged – probably not the best approach – how to resolve those differences with DEC and good planning to what FEMA will actually support which is put the trail back right where it was and that is what we will pay you for. Trying to get beyond that – improvement/better way; Councilman Messa - 1. Legacy Dam - both in Paris and New Hartford - that has tremendous amount of rain – we should start there, channel energy there, helps a lot of people down stream 2. Hand Place – stabilization of the banks – they've lost property, may take time – you have to start somewhere, have a plan; Kristen – having meetings here would be a great option to spread the word of what we are doing – to see us work as a group; Councilman Messa – the dam is a great start – allocate more funds there – starts there and goes downstream; Kristen – we can look at chasing funding, examine the Legacy Dam – cost effective, whatever comes out of it.; Councilman Messa – whatever we can do, appreciate it.

Councilman Lenart introduced the following Resolution for adoption and seconded by Councilman Messa:

B. John Dunkle and Jason – Engineers – talk about flooding in the Town – next moves with surveys – time put in with Ward 1 and 2 projects; average rain fall in July in Utica is three inches, we've had at least eight inches already and we're only halfway through the month. We've had a lot of problems with the tributaries in all the Wards. This last storm, were all areas we predicted, there was flooding, has been and will be again until we can start to implement some of the recommendations that we've made in the studies in Ward 1 and 2. We can identify the problems and tell you what the

solutions can be, the hard part is actually getting it done (of course that takes money). - Estimated, just for Ward 1 (\$15/\$20 million) to do upgrades needed. We've got a lot of work to do to prevent the flooding. The Town has been doing a lot – Highway Department. Question is – where do we get the money – believe we have six funding applications out there right now for various projects in Wards 1 and 2 – we have to, if we want to move forward and help residents – so its not a chronic issue every time it rains, we have to think bigger or try to find ways; Town Attorney Herbert Cully – I've heard a lot of criticism from residents that the Town allows development to go forward and that's the cause of the problems that we have. Can you explain if someone comes in with a project today, the steps you take to ensure that stormwater is properly being handled; John Dunkle – we have pretty high standards for what they need to do when they develop, any development moving forward, we are doing to work to not make flooding worse. In terms of generating funding – creating special assessment districts, for like, each water shed and so, the special assessment district then generates revenue through participants in that district and then the money is dedicated to making those improvements; Town Attorney Herbert Cully – to do that, they would have to be a definite cost, it would have to be published, have to have a public hearing, participation of voters as to whether or not they want to foot the bill; John Dunkle – it is a possibility if you have the support of the community to do, almost like a self-funded, it can supplement the grant money; Town Attorney Herbert Cully – when you do you computations, I assume you are looking at historic records as it relates to water flow – are your records taking into consideration the accelerated situation we've had in the last five/six years; John Dunkle – the participation data we have is current; Councilman Reynolds – work on Foxcroft – you've identified another segment that goes west affecting Gilbert Road, Jordan Road, Paris Road, Genesee Street – I know you are working on that; John Dunkle – we have five ongoing projects; Jason – we have met with residents in Tangelwood, we have looked at the watershed – its about a 138 acre watershed that comes to Tangelwood and its trying to be supported by some 24 inch pipes and there are some houses that are sitting lower than roads and there's not a lot of flood plain through there and subsequently they are seeing flooding, just can't handle it; Councilman Messa – 9 Beechwood – water cascades down between the houses – has retention pond there – basement got water – see what we can do – the one grates gets clogged – heads right to the house – is the answer another catch basin; Jason – is it an area we looked at during the study – will add to our list and take a look at it and when we look at an area we look at more than just one (Mrs. Kennedy has a video Jason will take a look at); John Dunkle – if we did everything on the plans we recommended, there's still going to be flooding. There is still going to be flooding in people's backyards which we are not looking at because we are looking at ways we can make improvements on public land, public infrastructures. We (the Town) can't be going in and remediating private property issues with drainage flowing from one property to another; Councilman Messa – the other two - Palmer Creek (Mallory Road) and Robert's Creek - areas that flood (lower and middle) – Jason will at it if show the specific area and can let know if it is an area they have already looked at and can tell exactly what is going on; Supervisor Miscione – Rick and Paul have been out in the public and educating a lot of the residents that have a lot of tree debris that they throw in their backyards – people who

cut trees and leave them there – trees flow and jam up the creeks – ask residents to bring out front for Highway Dept. to pick up, not put in ditch (which causes a jam). Cascade Drive for instance this week – logs up stream, blocks culverts – maybe educate community through the Town Crier – maintenance on private property that the Town can't go out and clean.

- C. Ms. Nancy Graniti owns property on Elm Street in Chadwicks they had a lot of floods during Halloween – still a mess – asking what help they are going to get to help the area; Supervisor Miscione – Legacy Dam – one of the things that will help in that area; John Dunkle – we looked at that area too, we put in for a grant to expand the culvert on Oneida Street to try to keep the water in the creek where it belongs; Ms. Graniti – whose responsibility would it be to take the logs out, the owners, correct; Supervisor Miscione – if it comes down stream, the Town is here to help the residents. The Town can't legally (through the State), go in someone's backyard to do private work to clean that kind of stuff. We look to the residents to keep their own backyards clean and that helps the creeks downstream and everyone else too; Ms. Graniti – you try to keep your property up kept and you have others that don't; Councilman Messa – Maybe code violations; Ms. Graniti – maybe that's the answer. You try the best you can to up keep it. Someone should come around and look at it; Supervisor Miscione – next Town Crier ad, do some awareness on this; Councilman Messa – can we send Larry to take a drive through Elm Street, to see if there is anything that sticks out; Supervisor Miscione – yes, we can – one issue, there are some issues over there that we had to go on the neighbor's lawn to take pictures to send a violation letter. There are current issues down there we are working on – all private property – if you see something major; Town Attorney Herbert Cully – maybe we should amend our code as well; Supervisor Miscione – asked Nancy to contact him tomorrow – show pictures she has, could be an issue currently have – see what we can do
- **D. Robin Kennedy** retention pond is not doing its job thanked Chris and Rick for coming out – need a more permanent solution – it was done in 2013 (called it a band aide) – unfair to blame residents – something needs to be done – retention pond is not sufficient – wasn't 25 years ago and not in 2013; John Dunkle – Beechwood/Janet Terrace/Wills Drive has three – have looked upstream to add some detention further up to watershed and also improve those to increase the capacity – not going to hold back – more needs to be done in that watershed; Jason – these is a lot of debris over there – it doesn't come down – it clogs up – they don't function the way they should. The Town does maintain it, they do go over frequently. As these high lows come down these creeks there's erodible dirt and it brings down material every storm. They are constantly over there cleaning them. That is one of the big problems over there, there is a debris issue – there is very erodible soil – the high velocity of these little creeks that aren't stabilized, they are natural creeks on private property that bring down debris, the debris clogs up the facilities then they have to go over and maintain them. It happens during the storm, there is nothing that can be done at that time. It is something that we recommended in our report that debris control be added to these facilities; John Dunkle – also looked at adding more stormwater storage upstream to help them function better too and to say they completely don't work is not a correct

statement because they do handle some of the storms. If they weren't there, you'd be seeing much more frequent flooding. They fill up quickly, they get clogged. This is happening during the rain fall event. Just to tell you how much they do – there is a vast area, these kinds of problems are throughout the entire county. As they find the problems, they are corrected. They are happening more frequently, its very difficult to keep up with it. That's why we recommend some debris control basin that can be cleaned out. Its another settlement area – more accessible – catches branches; Highway Superintendent Richard Sherman – each detention pond we have has four basins that catch gravel, stone, etc. so we don't have to clean out the whole pond; John - sometimes it happens during the storm, there is not much you can do - dangerous conditions – high flows – can't just send guys in while these events are happening because guys can get picked up; Chris Moran – once it floods up, its to far. We went to Beechwood and that had already come up over the head wall and a couple of the homeowners down stream were trying to keep the overflow open which it was but it was to late at that point. These ponds cascade down, three of them, there's multiple inlets into the structures that are in these ponds – there's little openings that slows the water down, there's the overflow grate in the top, and the dam that goes over. Once those top grates plug, the whole pond fills up and it's coming over with all that debris. The debris is plugging the head wall and we can't get near it. The best we can do is try to keep the over flow open; Jason – these facilities all have outlet structures that were built for resiliency so if one thing clogged the other thing would not function. You're getting such high flows; they're clogging all at once; Chris Moran – over flow structure – maybe lower it down a little to catch more.

E. David Mier – 9293 Mallory Road – thanked Councilman Messa for responding to emails – thanked Rick for the sandbags – concerns about tax districts for flooding – concerned about the other side of Mallory Road – severe erosion on his neighbors' side – 4 x 10 culvert that moves a lot of water; Councilman Messa – Asked David to give Jason his address so can come take a look; David – Palmers property – perfect opportunity to get land so that something can be done – Palmer Creek comes down Sessions Road/Graffenburg; Highway Superintendent Richard Sherman – excavator will be there in the morning to get the tree and gravel bed out; Jason – we did study that are and we did come up with solutions to help with the water problems. We proposed a detention facility up in the fields, in that area, came up with quite a few issues in that area.

III. PRESENTATION/COMMENTS

A. Omar Massoud – under the understanding that moratorium has been lifted on solar farms in the Town; Town Attorney Herbert Cully – yes; Omar – Ok I have with me tonight Matthew McGowan, Ascert Renew – I hope to release my land for that project; Matthew McGowan – Ascert Renew Solar Farm – understanding is to proceed with the Planning Board and look for a special permit. Further understanding is to go through the Zoning Board and ask for an overlay district to be created at the property. What direction is preferred?; Town Attorney Herbert Cully – Zoning Board has no jurisdiction over the solar farms. It would initially go to the Town Board, a form would be completed, it would come to the Town Board. The Town Board would approve that location. Then it would go to the Planning Board. You would apply for a special use permit, they would give a recommendation and then come back to the Town Board. The Town Board would hold a Public Hearing and then would make a determination as to whether or not they felt it was appropriate. The Planning Board will look at the size, the landscaping, the buffering from neighborhoods, proximity to neighborhoods, etc. The details will be weeded out through the Planning Board but the initial approval is to the Town Board to say 'yeah I think this is a great spot for it.' The Town Board has full authority to permit it to go forward or not – have a NYSERDA form and happy to give to Omar so you can get started.

- A. Highway Superintendent Richard Sherman
 - 1. Report on Curbside Trash Pick Up a copy of the spreadsheet was handed out broken down by Wards by Loads/Tons/Amount budget was \$32,000 total amount was \$25,525.60 ending balance of \$4,874.40 didn't go over budget.; Monday drop offs are still popular average three truck loads; Shredder in the past 3,000 tons of shredding paper was free, anything under 3,000 we had to pay for the free is gone now they charge us for whatever they come and take waiting to see with budget next month and if can afford another shredder in Oct. before the bad weather.
 - 2. Ongoing Jobs (still working on jobs from previous presented spreadsheet); June/July still did brush and green waste pick up, mowing completed two times around, all County and our roads that the Town does; detention ponds have been mowed once, had a lot of brush from wind storm on July 6th; drainage work during that time period, been working on Woodberry Farm (on going ½ to ¾ way built), need to install some pipe in the pond itself; still have dirt removal to continue with; 48 Taberg Road replaces 150ft. of 36 inch pipe that was in our

right away; did two driveway pipes at 6 Sullivan Glen and 9 Knollwood; installed a catch basin at 17 Stonebridge for stormwater; 25 Clintonview - had complaint - needed to go in and do drainage work; Blacktop repairs - Stonegate Road (behind Stonebridge) - large repair - started on Sherrill Lane; Councilman Lenart – Paving – road deterioration on Cascade Drive – by the culvert (Rick commented it will be fixed this year); Highway Superintendent Richard Sherman – Kingfisher Lane, Heatherwood Drive, Oakdale Ave. and Sherrill Lane – catch basin repairs; Milled – part of the city line to Kellogg Road and Elm Street to Paris line. Hand Place has also been milled – getting paved on Friday and Saturday (maybe Monday); Oneida Street to Kellogg Road – 900 ft. after took out 1½ inches to 2 inches – with the rain, it blew apart – had pot holes that started to be 4-6 inches deep – made decision to call Emergency repair which want to get approval for. Got the portable street lights/traffic signals rented from Syracuse – hired a contractor under the emergency repair – took out the concrete road, tomorrow will black top – had to rent/borrow piece of equipment to use – to cut concrete. Rebar was up (could pop tires). This is why it was an immediate shut down; Past two storms – met with residents on Tanglewood to see what can do with engineers – called and brought sand bags and will see what we can do; Whitetail Pond – cleaned; Councilman Messa – talks about going further up; Highway Superintendent Richard Sherman – the debris – it is rocks and gravel that keeps coming down and getting caught – out there during the storms – unsafe for the guys to be out there – Head wall on Beechwood is the most dangerous place we have and Woodberry – you could lose a person in the swirl – can't get equipment back there; project on Oneida Street/City line – had meeting with Jason – he manufactured a pipe – was supposed to be delivered two months ago – talked to the manufactures and he couldn't get the material to make the pipe promised pipe would be made on Friday, once make it, they press it and its oblong to get the water through – see if can get a truck here by Tuesday – contractor can start on Bradley Road and come to Oneida Street. Still up in the air on Oneida Street with the Water Board, a design, we have a 12-inch gas main in the way, a water main in the way, trying to do something without having to move watermain. Goes back to Oneida Street Soil and Water – this has been out there for four years – ongoing; Speed limit signs - Paris sign, solar signs; Stop signs put and more will be installed; new batch of street signs delivered this week; Councilman Lenart – street lighting, where do we stand; Highway Superintendent Richard Sherman and Supervisor Miscione – waiting for a call back from National Grid – acquisition to buy it back – going through the State level now
