# REGULAR MEETING OF THE TOWN BOARD OF THE TOWN OF NEW HARTFORD, NEW YORK, HELD AT TOWN HALL, 8635 CLINTON STREET, NEW HARTFORD, NY ON WEDNESDAY, OCTOBER 20, 2021 @ 6:00 P.M.

# I. PUBLIC HEARING

Town Attorney Herbert Cully – as the Board will recall, on July 14, 2021 we passed a Local Law providing for the installation of a stop sign on Janet Terrace at its intersection with Wills Drive. We held a Public Hearing; Local Law was passed and stop sign was installed; a gentleman approached the Town Board – he had some concerns about the process – he was concerned with the stop sign and felt that created a dangerous situation with a stop sign – The Board decided they would like to hold another public hearing on the issue of whether or not: 1. You should rescind that prior resolution and thus eliminate the stop sign or 2. in the alternative reaffirm that Local Law and allow the stop sign to exist 3. To replace that stop sign with a yield sign. This is a Public Hearing to ask for public comment as to whether or not the stop sign should consider to exist, whether it should be completely removed or whether it should be changed to a yield sign.

- 1. Carol Gschwind 27 Janet Terrace lived there since 1960 thinks a yield sign would be sufficient, doesn't think a stop sign is necessary
- 2. Mitch Ford 45 Wills Drive lived there six (6) years called back in June for a stop sign – twice have come down the street: first time I had plenty of time to avoid a collision, second time I slammed on my breaks on, veer to the left and almost ended up on someone's front lawn. That is when I called the Town and said something needed to be done. People are going up that road faster and faster. My family walks on those roads (Janet Terrace and Wills Drive). Just because there haven't been any accidents there in so many years, something is going to happen at some point. It has almost happened to me twice. If you don't have any signage – and someone gets hurt – are there any repercussions the Town can take for that?; Town Attorney Herbert Cully – sure, they can sue; Mitch Ford – it is a safety issue – asked police chief who would get a ticket if there is no sign; Chief Inserra – with no sign, its subject A against subject B (driver 1 said this driver 2 said this) – going to be honest with the Board – that intersection does need signage – should be a stop sign – yield signs still leave a lot of interpretation to determine who is at fault – you might not see people walking or kids – stop sign certainly establishes this car must stop and if there is an accident, that car is at fault, very easy to investigate; Mitch Ford – Councilman Lenart asked a question last time if a stop made a difference – Mitch Ford responded – yes, people do stop there, its very effective. Stealing signage is a crime – it is very disturbing that someone had the guts, go take the bolts out, leave the bolts out and take the sign took – it has to be in someone's garage. If there was an accident at that point, and that sign was gone, there would be a real problem.; Town Attorney Herbert Cully – so your position is that we should leave the stop sign as is; Mitch Ford – yes, leave the stop sign; Chief Inserra – is it possible to put a stop line; Highway Superintendent Richard Sherman - yes, we can do that.
- 3. Robert Vanderlan 6 Wills Drive people are slowing down a lot.

#### V. MATTERS SUBMITTED BY TOWN ATTORNEY HERBERT CULLY

1. Prior Bid that was awarded at last meeting for Mud Creek Dam Project –one bidder objected to Marcy's bid because more than a MAX. of 5% for mobilization was included in the bid; After the Board awarded the bid, John Dunkle received an email from the challenging contracting stating they awarded the bid to someone who was also over (he challenged the award).; Town Attorney Herbert Cully – By the Law, a Town has a right to waive a technical, non-compliance if it feels it is in it's best interest in connection with awarding the bids. The thought is, we re-affirm the bid and waive the technical, non-compliance of exceeding the 5%. The reason being, because now the 60 days is gone on the bids and we would have to scratch them all and start over (re-bid the whole the whole project again); John Dunkle – this was a technical, minor issue. In the contract, the bid item, there is payment item for mobilization – in the payment item it says that item should not exceed 5% of your total bid, excluding the other items; Town Attorney Herbert Cully – we would reaffirm the award, subject to the modification that no payment be made in excess of the 5%. The Law is – if the Board is acting in good faith and there is no collusion, it's of no significance and Keller already offered that.; John Dunkle asked Town Attorney Herbert Cully – to respond to the challenger (contractor) going forward.

# VI. ADDITIONAL MATTERS SUBMITTED BY TOWN SUPERVISOR

1. Additional Cash/Checks found in the Town Clerk's Office – should send in state from the Comptroller's Office to audit – finding cash and checks dating back to 2019 – what happened to 2017 & 2018, etc. – right now with what Cheryl has been doing, everything is up to date with cash receipts the Supervisor gets from the Clerk's Office – previous to that (before Cheryl), we've had numerous discrepancies from all these deposits to what is on the monthly reports and what has actually been deposited. This is ongoing and becoming a problem. This time \$380 was found in an envelope box (not labeled) with other envelope boxes, on the shelf with letters with Melody Fancett's name on them saying 'will return your cash' but letters were sent and cash was still attached to the application; Supervisor Miscione asked Town Clerk to contact the Comptroller's Office; Town Attorney Herbert Cully – Councilman Reynolds had asked me to pull up the Law. The Law requires the Town Clerk to maintain a daily log of all monies that are taken in. Councilman Reynolds asked where that log is; Town Clerk Cheryl Jassak-Huther – all I know is, since I've been here, we date stamp all incoming correspondence, log into an Excel spreadsheet every day (date on envelope, date received, what for, from who, check or cash, and any other information needed); Town Attorney Herbert Cully – the other aspect is, the Town Clerk has to deposit all monies received when they exceed \$250 within three (3) business days of when received; Town Clerk Cheryl Jassak-Huther – during tax season, when Jim from the County came in to help me fix all the discrepancies, he found a deposit that had sat in a desk for ten (10) days of over \$380,000 in checks before was deposited (we showed Paul); Supervisor Miscione – also, we're missing all kinds of documents from computers in the Clerk's Office from everything we've done in the past couple of years. They've been deleted (FOIL requests, Public Notices, etc.). Will be sitting with IT to review this matter; Councilman Messa – since they found this box, did we do a sweep of the office; Town Clerk Cheryl Jassak-Huther – we've cleaned the Clerk's Office – started cleaning Washington Mills Building – also cleaned all Clerk's files in the back room (each box was gone through paper by paper, then boxes were labeled and places on the shelves in the caged (now locked up). When we found the money, we called each person to see if still needed the documents before sending the money back. A record is kept of every application/check/cash found and send back.; Supervisor Miscione – has already let the auditors know; Councilman Reynolds – is there anything still in Washington Mills; Town Clerk Cheryl Jassak-Huther – I have cleaned 50% of it; Chris Moran – there is stuff from the 70's, maps, etc. Most of the Town Clerk's Office has been brought over to the Town Hall already; Town Clerk Cheryl Jassak-Huther – we have labeled everything but a lot of years are missing. The girls and I have come in on weekends to clean the back room and 90% is done and gone through. Just ask permission to send back the money back to the applicants.
