- B. Discussed Budget lowered raising substantially, moving it over to have administrative help for the Board and the Supervisors Office; Changes:
 - 1. Councilmen decreased to \$12,000 per person

 - Town Supervisor decreased to \$32,000
 Added \$18,000 to Supervisor Secretary budget to add another part-time person – summer hours/summer program (A1220.13 page 3)
 4. Added \$12,000 to Accounting Department (A1315.14 page 3) – part-time
 - help to help with day-to-day accounting, prep work and bills
 - 5. Added \$10,000 to the Codes part-time secretary (BB8010.19 page 13)

- 6. Police Officers two new police officers will be added for the 2022
- Budget (full-time) for neighborhood patrol/safety/call volume
 7. Senior Center few years ago, \$13,000 was put in for kitchen equipment, to purchase additional equipment when the building was built (page 7) – 2019 year the total expenses for employment was less than currently budgeted – if need be, if contracts and programs continue, we will be able to use funds that we can transfer over from fund balance – the equipment was
- a one-time thing and that is what was taken out

 8. Still under the 2% tax cap by \$73,000 total increase in the budget is \$62,000 overall mostly going towards pensions and health care funds; everyone will get their tax cap check back at the end of the year, the numbers are way under the tax cap; added administrative people that we need to serve our residents
- 9. Positions are all part-time/no benefits
