- B. Audit 2020 Financial Highlights
 - 1. At the close of the current fiscal year, the Town's governmental funds, excluding the Capital Projects Fund, reported combined ending fund balances of \$9,838,082, an increase of \$629,731.
 - 2. At the end of the current fiscal year, unassigned fund balance for the General Fund was \$2,717,916, or 74.1 percent of total General Fund expenditures and transfers out. This total amount is available for spending at the Town's discretion and constitutes approximately 84.0 percent of the General Fund's total fund balance of \$3,236,936 at December 31, 2020.
 - 3. During year ended, December 31, 2020, the total fund balance of the Town's General Fund increased by \$24,448 during the current fiscal year, primarily as a result of savings within general government support expenditures.
 - 4. During year ended, December 31, 2020, the Police Fund's fund balance increased \$307,363 as a result of savings related to public safety and employee benefits expenditures.
 - 5. During year ended, December 31, 2020, Highway Town-wide Fund balance increased by \$83,372 due to savings realized within transportation expenditures and increased revenue related to sales tax.
 - 6. During year ended, December 31, 2020, Highway Part-Town Fund increased by \$121, 734 primarily due to savings realized within transportation expenditures.
 - 7. During year ended, December 31, 2020, the Sewer Fund's fund balance decreased \$12,498, primarily as a result of more than anticipated employee benefits expenditures.

 - 3. 11 Center Terrace Town Attorney Herbert Cully owner is Janet Marsh she has not resided there for a period of several years; Google searched and found relatives and spoke to a

- daughter; Town Attorney Herbert Cully there is an open mortgage with Adirondack Bank taxes are paid Dory talked to daughter who put her in touch with another daughter which gave her information told Dory they are in the progress to see what they can do to rehabilitate the property or just get rid of it; nice house, can be flipped; Dory is calling daughter back
- 4. 17 Medford Place Fire that destroyed the home on November 1st and letters keep coming back; Councilman Reynolds was in violation before the fire never got any complaints, last house on the road left off of Rt. 12 in violation long before the fire unsafe structure
- 5. 9364 Elm Street Town Attorney Herbert Cully should commence proceedings against that, in bad shape, as long as the Town is aware of the cost of demolition, etc., and try to add it back for taxes; Councilman Messa its been on going, getting numerous phones calls on the property; Town Attorney Herbert Cully will initiate the action Lary has to give a report to the Board at the next meeting, mail a copy to the resident (even if the person is not getting it getting returned mail), then the Board will make a Resolution to go forward with demolition

Supervisor Miscione – there has been a lot of work done on all of these – the Codes Department has kept up with all of these 100%, Supervisor Office and Town Attorney Herbert Cully as well – spending a lot of time, getting a lot of resident's calls – want something done, need to go to the next step. We have done everything we could.

Real Estate Appraisal and Consulting - Per the letter from Donato: I have completed a restricted appraisal report for a new access road that has been constructed (Wishaway Woods Lane) as an offshoot of Ironwood Road in the Town of New Hartford. The subject road is a total of 363 linear feet with a cul-de-sac at the end. The subject road has 110 feet of frontage (width) at Ironwood Road, then narrows to 90 feet for 152 feet long, then opens to a cul-de-sac with a 180 +/- foot diameter. The road contains a total of .854 acres and meets all criteria for a public road (width, turning radius for emergency vehicle access, etc.) The road is paved and has natural gas lines, public water lines with laterals and T's, public sewer lines and fire hydrant lines. The cost of the road is in excess of \$275,000. The function of this report is to determine a value of the road, which is being dedicated to the Town. The \$275,000 cost discussed above does not include the value of the land, this amount is the estimate of the improvements on the parcel (paving, water laterals, etc.) The value of the parcel, as improved is considered to be the cost of the improvements (the improvements are new and have not experienced physical depreciation) plus the value of the land, estimated to be a total of \$300,000.; Town Attorney Herbert Cully – we have met all the requirements for a dedication except for a Resolution from the Board agreeing to the dedication and accepting it as a Town Road.
