 Senior Center, Program Manager and the three working part time no more hot
 meals money still in budget advocating for the Seniors
- ii. Marsha Smith Seniors need to be taken care of miss having the informational programs that can be planned by a Director miss the hot lunches and the socialization during the hot lunches none of this can be done by volunteers, it's a professional job that needs professional attention
- iii. Marie Duink 52-year resident concerned about the Senior Center proposed a committee be established to see how can enjoy hot meals and activities
- iv. Bob Hook stated grants are provided by all States for Senior meals (Supervisor Miscione stated they are provided to the County, not municipalities people can also be volunteers, no requirements for paid employees the County administers)
- v. Michael Miles here for an update on 41 Bolton Road (Town Attorney Herbert Cully stated nothing has happened since the last meeting we noticed Sitrin that we feel their application is defective and they cannot proceed with a defective application and they have not secured a building permit nor they have come to the Planning Board seeking a site plan approval. We have received no further communication from Sitrin. Our Codes Officer has been driving by there on a regular basis and he has seen no activity in the form of construction.); Michael Miles spoke about the letter from Sitrin CEO Christa Serafin; the Mental Health Law clearly states you have to tell the municipality the number and they have not done that); Town Attorney Herbert Cully that is why I sent the letter and the Board indicted their support that in fact their application is defective, nothing has changed since that time; Michael Miles you have written a letter and she has responded to you where do we sit; Town Attorney Herbert Cully if they proceed to do construction work then our Codes Officer is in a position to

- issue a violation notice because they are not permitted to do that because they have not followed the proper procedure; Supervisor Miscione another addition went through documentation that had to be sent to the Town of New Hartford a certified letter would have had to go to the Supervisor never received a certified letter that was on State documents if that was done; Michael Miles Lisa Frank sent an email and stated a certified letter was never sent also there are deed restrictions on these properties, one is no businesses, private residents; Town Attorney Herbert Cully private deed restrictions that run with the land and can be enforced by people who are in that subdivision, the Town doesn't enforce private deed restrictions spoke about the saturation (determine if it is above the saturation level)
- vi. Patty Mitro addressed more about the letter that was sent back to Town Attorney Herbert Cully from CEO Christa Serafin, she clearly states she has no intention to resubmit a letter of intent (Herb that is why the Board took the action the last time) she is ignoring that; Town Attorney Herbert Cully the Board has supported Town Attorney Herbert Cully that their application is defective and that they need to come forward and get a site plan and building permit. If they take action by starting construction, we are going to notice them for deficiency will not respond to Sitrin feel position is correct if they go forward that is what we are going to do; Patty Mitro to me, the letter from Sitrin was sarcastic and demeaning to all of us (Herb don't disagree with you in the least the Board is in agreement their application was defective).
- vii. Supervisor Miscione looking into certified letter the State requires that will keep all the residents up to date
- viii. Greg Chesebro spoke about the saturation asked if the Town is going to support the neighbors (Supervisor Miscione yes, 100% also will call Assemblyman Miller about the saturation); also, the Law is they have to notify the neighbors too and we have had no letters
- ix. Mike Dennis spoke to the OPWDD does the assessment needs to come from the Town the Town has to formally object it to start the process (Town Attorney Herbert Cully will go forward and contact them to provide us with any and all information (FOIL) with regards to the determination of saturation
- x. Shannon Guernsey 9522 Roberts Road speed limit looked into it was 55 MPH, then 50 MPH, it is a County Road one of the fastest ones surrounding it are 45 MPH asking for request to have it moved up and looked into
- xi. Patricia Femia 45 Woodbrooke Road (representing neighbors at 43 and 47 also)
 basements floods (Highway Superintendent Richard Sherman are in the cue for May/June will be notified when the work is going to start)
- xii. Mischael McKenna also here about Bolton Road asked if the Board is really going to not allow this to happen when we don't hear from you, we all get really nervous (Supervisor Miscione correct, we also got new information tonight and will look into that)

- xiii. Marie Duink asked if there will be any action taken on the Senior Center (Supervisor Miscione – if the Board brings an action, we will move forward – the Bolton Road project we have been working closely with and we are to protect the neighbors and their properties are protected); Marie Duink - we do not know the concerns are – unable to address the concerns; Supervisor Miscione – we have opened the Senior Center – we have not closed it – we can set up the programs, we have all the numbers; Nancy Marafioti - it takes 20-30 hours a week job to set up programs – professional person that is paid; Councilman Reynolds – I think the points about the program are very important. The Center needs to be open, get the hot meals back and pay our current staff; ; Town Attorney Herbert Cully - we have had a public comment period that has gone beyond the extent of a public comment period, public comment is directed to the Board – it is up to the Board whether or not they want to respond – we have rules for a lawful meeting - in fact the woman that just stood up and made comments to the Board is clearly out of order according to our rules – a motion has made – the public comment period is now done because we now have a motion – is there a second? – if there is no second, the motion fails
- xiv. Supervisor Miscione can meet with your Senior Center Committee members Councilman Reynolds and Councilman Lenart; Senior Center is not closed has never been closed
