A. Bolton Road

i. <u>Town Attorney Herbert Cully</u> – little history – been important for some period of time – the judge has allowed several adjournments in an effort to try and settle this without the court having to make a decision – Herb provided a proposed settlement to the Board that came from Sitrin – limiting the number of residents that would reside in house to no more than five (5), that would be done by stipulation and court order – also some additional items listed – have been several meetings with the residents – this appears to be the best offer that Sitrin has come forward with – don't anticipate that they will offer anything other than what have – expressed concerns that if it isn't settled, either the court will deem our objection because they said four individuals rather than five individuals, saturation etc. and Sitrin did provide documents that the list was accurate – Up to the Board to settle; Sitrin indicated that we have been stalling this and the results cost of contractors has changed; Councilman Lenart – we would be free and clear if we settled; Court date set for Wednesday 3/8/2023; Residents made a

presentation on their thoughts and feelings about Sitrin moving into their neighborhood and were against it; Councilman Messa - asked Herb to speak more about it – Herb – if we had offered an alternate site, and said Genessee Street would be a site to look at and Sitrin said No, there would be trial in front of the Commissioner – if judge throws it out, Sitrin can start over – under the way the law is written, it is very difficult to overcome these homes in a residential neighborhood - Sitrin doesn't feel the suggested site is what they are looking for – the whole intent to this law, is to allow disabled individuals to reside in residential settings, not deemed a business under the law; Councilman Messa – a letter was sent to the Town, had 40 days to respond – that wasn't done, so no law was broken (in Messa opinion) - if it goes to the process again, they can have more residents then what they have proposed before; Councilman Lenart – we could also have a law suit against us for a lot more money; Councilman Reynolds - this does change the character and nature in the Bolton Road neighborhood – they have been given different locations that are more ideal (lighting, sidewalks, access to road, etc.) – this will have a negative impact on the neighborhood; Councilman Woodland - asked if the judge was leaning more towards Sitrin; Town Attorney Herbert Cully - Sitrin has taken a strong position that the Town has discriminated against disabled individual and we have delayed this, cost of construction will be going up – lawsuit, monetary damages; Supervisor Miscione – little background – didn't receive the letter – called the State and they said should have had a certified letter – raised a red flag – was never served a certified letter – anything this major, people reach out and talk about their project, in fact, reached out to CEO at Sitrin and had no response back or call for any meeting - Sitrin is a great organization, don't understand why didn't reach out to the Town Supervisor – this is business in a residential neighborhood - Genessee Street location is a nice location and might be more suitable for this project - NYS comes up with their laws for a lot of things - this is a residential community not a business community - concerning for me - there need to be a way to put a to stop to these projects/laws we don't have a say in -Ihave been against it for those reasons - from day one, the process was wrong, should have gotten a phone call after didn't receive the letter; Town Attorney Herbert Cully – will need an answer from the Board as to if they want to settle
