- A. Councilman Messa
 - i. <u>Project Progress Update for Roman Road and Hughes Lane</u> work is currently underway; thanked Rick and Chris; Highway Superintendent Richard Sherman gave an update that trees have been taken down, building a road, moving forward on the project

- ii. <u>1st Ward Roads for 2024 paving consideration: Beechwood, Danbury, Forest</u> <u>Road, Sherrill Lane</u> – Highway Superintendent Richard Sherman said the roads are on the list for next year
- B. Councilman Reynolds "In-lieu" payment plan for Town Board Members and Town Supervisor; Councilman Reynolds does not feel it is the way; it is an \$8,500 raise in his opinion, it is not right, it may be totally legal but it is night right, it's a sustainable raise, if someone is here for the money or benefits that is not correct; Supervisor Miscione – explained how got here – takes the insurance – we had person who worked at the Town two days a week for \$50,000 a year and Supervisor Miscione took on the responsibilities for a the healthcare, it was already in the budget; the Board didn't get the raises from years prior; every other elective official gets the option of healthcare; money was not added in the budget; if you take it away, then you have to hire someone, it was money saved by not hiring another employee; Councilman Reynolds did not vote for the lieu, it was a back door raise and it is not right; Supervisor Miscione – it was to replace a position, it was transparent, saved the residences money; increased our parks, have a great building, best bond rating; Councilman Reynolds – it is not right to take in Lieu of, no one made a motion for Lieu of; Supervisor Miscione – we said we would reinstate the In Lieu from previous (which we have resolutions stating that from years ago); Councilman Messa – I was at the meeting in December, if we are giving someone Health Insurance it is a benefit, it is a cost, if someone is going to get a benefit, a cost, it is the same thing; the only way to get around it is rescind the whole thing and to go back to the way it was and rescind it; Town Attorney Herbert Cully – the point is, from my understanding, the Town Board adopted a Resolution and possibly a Local Law that authorized the Health Insurance for the Town Board Members and/or the payment in lieu. If it was done by a local law and the local law said it could be amended by Resolution it can be amended by a simple resolution. Now what I drew a local law to - (and clearly, the Town Supervisor and any elected official) the Town Law says you have the right to give Health Insurance to any Town Board Member. The issue becomes, do you have a right to give an in lieu of payment and the Law is, there is nothing in the Law that says you can't, there is nothing in the Law that says you can. According to the Association of Towns, if the prior Boards that in acted did it by a Local Law, a simple Resolution allows you to do it. If it wasn't by Local Law, they said do a Local Law, saying you can take the in-lieu payments, so I drew a Local Law - simple as that if the Board wants to go forwards with it; Councilman Reynolds - going back to the December meeting that Councilman Messa mentioned, that was the very first time in lieu was discussed to the Board; Town Attorney Herbert Cully – my understand, and I could be wrong, at least one Councilman, in one of the prior Boards (he is no longer a Councilman), did receive in lieu payments, so I think there is precedence that it has been done in the past, there is no prohibition, but the better way to do it, is by Local Law; Councilman Messa – everyone gets hung up on salaries and everything, 10-20 years, it was always a \$6,000 because they had the insurance of in lieu of, once that ended, the Board just had the \$6,000 salary; if you do the math, you are spreading it out over the years – kept salary the same – we do put in a lot of hours, each Ward is different, my point is you can't have one councilman

make more than another because busier; In lieu – you can do away with it, I don't need it - it is a benefit, everyone should benefit, not one should make a higher salary than another, if the Board wants to rescind it, I am on board with it, no in lieu of and no Health Insurance; Supervisor Miscione – the biggest thing is the embarrassment of it, we are doing good things, I take the Health care package, no one did anything that was bad or underhanded, it was clearly was in the budget. We built the building out, did the deal with the school, took care of the breaker at the Rec Center on my own Town, not being paid for it, I get the calls for the 2nd Ward now, it is out in the open. If you rescind it tonight, unfair midterm – should have done in Feb.; Councilman Reynolds – we should not get in lieu of, not saying don't get Health Insurance, you have to sign a document if you want the in lieu of, all councilman had to sign the document, in lieu of is wrong, it is a back door \$8,500 increase; Town Attorney Herbert Cully - doesn't think that Councilman Reynolds is objecting to Supervisor Miscione getting the health insurance, he is objecting to the in lieu of payment, it perfectly legal to take the in lieu and a number of Towns do this; Supervisor Miscione – it was in the budget when you all approved it back in 2022, it was a line item, everyone saw.; Councilman Messa – what I am saying is, all we did was reinstate what was there before and my point is whether you take the health insurance or not and you have the option to take the in lieu of or not, it is still someone getting the benefit is someone is getting the Health Insurance and that was how it was designed in the past and that is what we voted on. We voted on what was in there years and years ago. If you just give health insurance, it is still added on to whoever's salary, if do away with everything, then no one gets a benefit. It is a benefit from the Town for \$8,200. Some companies do give in lieu; Town Attorney Herbert Cully – a lot of Towns do it and its perfectly legal; Councilman Reynolds - I brought it up in December and I asked if needed a motion (for in lieu of) and no one wanted to step up and make a motion; Supervisor Miscione – it was said, in the meeting, if one is going to get it, everyone should get it, then lets rescind it and Supervisor stated it was reinstated how it was done before; Councilman Reynolds - I make a motion to rescind the in lieu of; Councilman Messa – and not the Health Insurance? You can't have both – it is one of the same; Councilman Woodland – I think it has to be all of nothing too; Councilman Reynolds – then do we have a motion to do all of nothing or nothing; Councilman Reynolds – it was not done properly; only time in lieu was discussed was at the very last meeting in December; Councilman Messa - Paul did state where the funds were coming from, they were in the budget, clearly stated and in there for years (that we never took out); Supervisor Miscione – at the time, we eliminated the Comptroller position, a \$40,000 position, plus retirement and benefits and I said I would take on the responsibilities for that (had no change because of it), we all win and we still get the job done for over two years now and successful with it, the budget couldn't have been more transparent to the residences, it was done in open session; Councilman Reynolds – I have a motion to stop the in lieu of (not the health insurance); Councilman Messa – I said it is all of nothing; Supervisor Miscione - we will have to hire someone to do the responsibilities if we drop the health benefits, to do the extra work – the Board made the decision in open session; Councilman Messa – we didn't make the decision in December

because open enrollment was closed – if you want to rescind it, you have my support, if you want to leave it as is, but it is all of nothing, that is my stance; Councilman Reynolds – do you want to make a motion to rescind it?; Councilman Messa – this is your thing, say it; Councilman Reynolds – I will make a motion to rescind it; Town Attorney Herbert Cully – rescind what?; Councilman Reynolds – the healthcare; Councilman Messa – second; Supervisor Miscione – all in favor (Reynolds said Aye, Supervisor Miscione said Nay); Councilman Woodland – so we are going to rescind the health care and in lieu of for Town Board Members and Town Board Members?; Town Attorney Herbert Cully – yes; Councilman Woodland - Aye
