V. MATTERS SUBMITTED BY COUNCILMEN

- **a.** <u>COUNCILMAN MESSA</u> we had another house fire in the area and the Code letter than goes out is a little harsh and insensitive, leaves a bad taste need to relook at the letter we send to residents; Councilman Reynolds states the Code black and white; Councilman Messa an opening paragraph to state this is a difficult time simple courtesy; Supervisor Miscione will write something and bring to the next meeting.
- **VI.** MATTERS SUBMITTED BY TOWN ATTORNEY HERBERT CULLY read: The budget must be adopted by November 20th and recorded in the minutes of the Town Board. It then becomes the Annual Budget for the Town for the next fiscal year. If the Town Board fails to adopt a budget by November 20th the preliminary budget with such changes that the Town Board may have made will constitute the budget for the ensuring year. So you have the Preliminary Budget with the changes that were made November 7, 2024, am I correct?; Supervisor Miscione yes; Town Attorney Herbert Cully and those changes were approved?; Councilman Tehan yes; Town Attorney Herbert Cully yes, ok we are set. I just wanted to be doubly sure.

VII. MATTERS SUBMITTED BY COUCILMEN

a. <u>COUNCILMAN TEHAN</u> – spoke about Tim from Bonadio coming to the meeting; One of the things we still need to accomplish is the completion of the 2023 and the half year through June of 2024 bank recons so that the audit can commence thereafter. We obviously have the estimate based on the hours that they would anticipate. They anticipated 2,750 per month, about 400 hours based on their estimates and the total would be \$49,500 for the 18-month period to do the bank recons. Tim noted that they would be able to start in December and get the invoice in January for the 2025 budget. I

recommend we go this approach. We have to get it done to get the audit to even be started at this point; Councilman Latini asked if we are going to go with Bonadio and mentioned Chris Lambert – he does municipalities, including Frankfort; Councilman Tehan – talked about getting alternatives; Supervisor Miscione – I want to get it done but I don't want to get it done in case someone comes in for a lot lower. Town of Frankfort pays an accountant there who does municipal accounting and they pay him \$1500 a month to do theirs. At least until the next meeting put it out to the public – get one or two prices because this isn't going forward. We know we are using Bonadio going forward, they are doing the front work but the back work, someone maybe can come in and give us a better price – save the Town money. See if competitive at that number – costly – get the best thing for our buck here. We never put it on the website or in the paper – asking for bank recs and trial balances for our 2023 audit – submit an RFP – we have a meeting on Dec. 10th so we have 30 days; Councilman Tehan – Cheryl if you want to post this, I suggest you use the same language that is in the Bonadio engagement letter we received. I will send to Cheryl for Herb and Cheryl to mark up and put in the paper and online.
