Heather Mowat – Planning Board Chairperson – met with engineer John Dunkle, was under the understanding that there was only going to be one entrance on Middle Settlement Road, DOT and/or County, more so the County, was looking for the entrance to be on the other side, asked Mr. Goodwin if was aware of that; **Mr. Goodwin** responded that Dory Shaw gave them the letter, Mr. Goodwin said that letter was a comment from the County with a multitude of other comments that were relatively boiler plate comments - their main concern was that they want to see that the entrances have proper site distance and adequate space between them and any adjacent driveways, they will respond back to the County's letter with what they want to see; they had a request that the connect be up to Woods Park Drive, however there is private land between the property Mr. Goodwin talking about and that road is not a direct connection to a public right away and do not have access to that land, can very well ask, but it is now Lowes, highly unlikely they will respond; the two entrances would be for fire truck access in case of accidents and would be further discussion in Planning Board Development Review, tonight simply asking for the Town of New Hartford declare themselves as Lead Agency; Town Attorney Herbert Cully spoke – thinks it should be tabled until receive additional information as it relates to the requirement to two or one driveway, thinks it would be premature to go forward with it based on the current plan and later find out its going to be one driveway and may result results in additional concerns and comments – until see final plans. Only person that saw the letter from County was Dory not the Planning Board or the Town Board; Councilman Reynolds – was concerned about parking; handicap apartments/parking, pushing snow; Town Attorney Herbert Cully asked the Board to table it was 30 days, reschedule/continue public hearing at the May 8, 2024 Town Board Meeting; in the meantime, the Town Board/Attorney would like to see a response to the County's letter

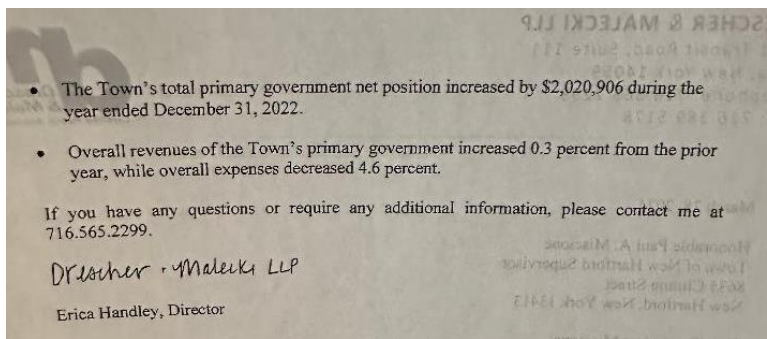
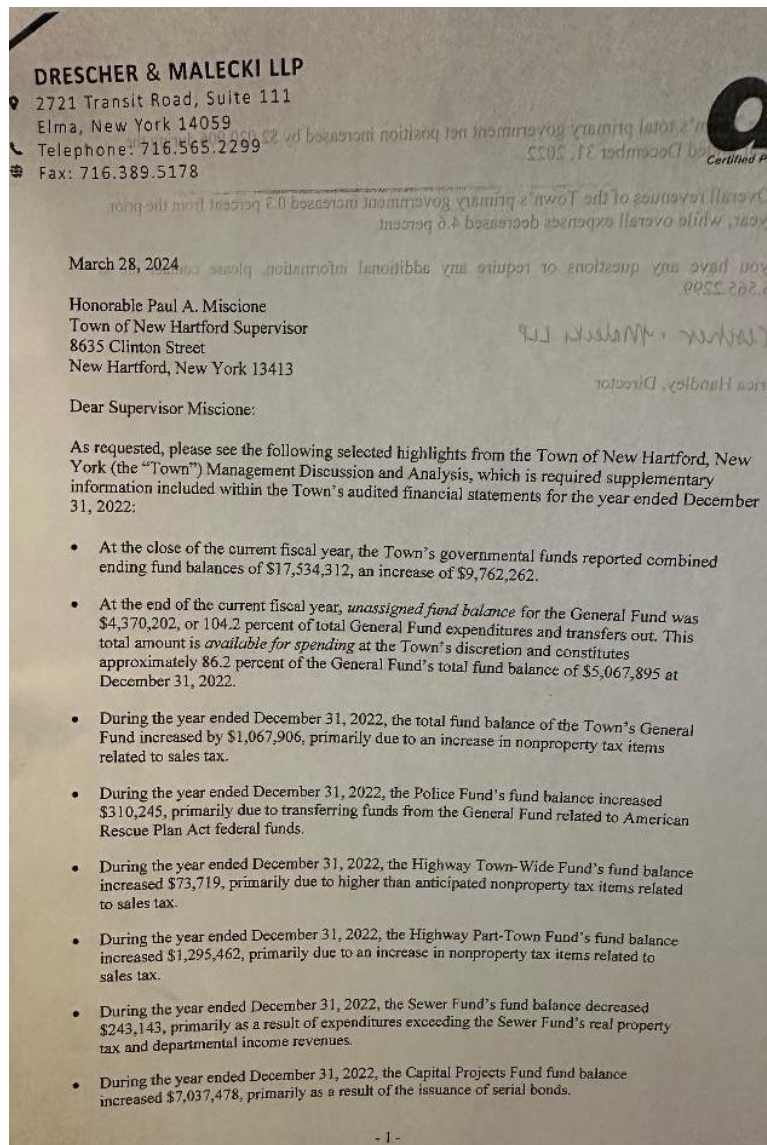
3. Final Completion of bank account reconfiguration – the Town of New Hartford is moving accounts all over to Adirondack Bank

does it – will look over everything and give comprehensive plan for a cost of approx. \$50,000/\$60,000; not justifiable to spend the money but if the Board would like to go in this direction, then will have to spend the money for the study but no one on the Board agreed to it; the auditors will come (they are out of Buffalo) but there is a cost for them to come to the Town Board Meeting. **Councilman Reynolds** - bring auditors in and everyone can ask questions – if everyone (the Board Members sign the letter) signs the letter, they will come, Supervisor needs approval – a motion was not passed for them to come and be paid; **Supervisor Miscione** – have a 3rd party come in (real municipal accounting firm), reports directly to the Board, there is no one at the Town full-time to watch them daily – have them come in quarterly, bi-monthly, that the Town is on the right track, numbers all come together (journal entries, trial balances), not someone that Supervisor Miscione has to oversee and manage – asked Councilman Tehan if could help find a Firm; **Councilman Reynolds** – asked Supervisor Miscione if will contact the auditors to come in, he responded yes, once a resolution is passed to pay them to come (it's a nine (9) page letter – asked Town Attorney Herbert Cully to review it first – will discuss on May 8th

2. **Councilman Tehan** – Resolution 210 of 2023 – hire a Comptroller; saw a challenge in one person; resolution is outstanding, better to maintain activity and proper oversight – will bring up at the next meeting
