# **TOWN OF NEW HARTFORD**

#### A LOCAL LAW IMPOSING A HOTEL OCCUPANCY TAX IN THE TOWN OF NEW HARTFORD

**WHEREAS,** the Town Board of the Town of New Hartford recognizes the growing number of visitors utilizing hotel and lodging accommodations within the Town; and

**WHEREAS,** the Town incurs increased costs associated with tourism, including infrastructure, public safety, and community services; and

**WHEREAS,** the imposition of a hotel occupancy tax is a commonly accepted method for municipalities to recoup costs and invest in local economic development and tourism-related initiatives;

NOW, THEREFORE, BE IT RESOLVED, by the Town Board of the Town of New Hartford as follows:

- 1. **Imposition of Tax**: There is hereby imposed and shall be paid a tax by every occupant of a hotel, motel, or similar place of lodging within the Town of New Hartford at a rate of 5% of the per-night room charge.
- 2. **Exemptions**: The following shall be exempt from the occupancy tax:
  - Lodgings rented for a period exceeding thirty (30) consecutive days.
  - Lodgings paid for by government agencies in the performance of official duties.
  - Other exemptions as may be determined by law.

- 3. **Collection**: Operators of hotels or lodging establishments shall collect the tax at the time of payment and shall remit the collected taxes to the Town in the manner and schedule prescribed by the Town Clerk or designated official.
- 4. **Use of Revenues**: Revenues generated from the hotel occupancy tax shall be designated for tourism promotion, infrastructure improvements, and other purposes as determined by the Town Board.
- 5. **Effective Date**: This resolution shall take effect upon filing with the Secretary of State and in accordance with applicable state enabling legislation.

**RESOLVED**, that the Town Clerk is hereby authorized and directed to take any and all necessary steps to implement the provisions of this resolution and to coordinate with state agencies as required.

# LOCAL LAW 3 OF 2025 TOWN OF NEW HARTFORD, NY

# A LOCAL LAW TO ESTABLISH A SPECIAL ASSESSMENT DISTRICT FOR POLICE PROTECTION SERVICES IN THE COMMERCIAL ZONE OF THE TOWN OF NEW HARTFORD

**WHEREAS**, the Town Board of the Town of New Hartford recognizes the increased demand for police presence and public safety services within certain high-traffic commercial areas of the Town; and

**WHEREAS**, Section 190 of the New York Town Law authorizes towns to establish special districts for specific services, including police protection, and to assess the cost of such services to the benefitted properties within the district; and

**WHEREAS**, the Town Board finds that the creation of a Special Assessment District for Police Protection (the "District") in the commercial zone will promote public safety, deter criminal activity, and enhance the overall business climate for residents, visitors, and business owners alike; and

**WHEREAS**, a map and plan describing the boundaries of the proposed District, the scope of services, and the method of assessment has been prepared and filed with the Town Clerk;

**NOW, THEREFORE, BE IT RESOLVED**, by the Town Board of the Town of New Hartford as follows:

#### **Section 1: Establishment of District**

The Town hereby establishes a Special Assessment District to be known as the New Hartford Commercial Police Protection District (the "District"), encompassing the properties located within the defined commercial corridor of [insert description or reference to attached map—e.g., Route 5 corridor, Sangertown Square vicinity, Commercial Drive, etc.].

# **Section 2: Purpose**

The purpose of the District is to fund enhanced police protection services, which may include:

- Increased patrols;
- Dedicated foot or vehicle patrol units;
- Surveillance systems;
- Public safety personnel;
- Community safety programs; and
- Related equipment and infrastructure.

#### **Section 3: Assessment**

The cost of providing the above services shall be assessed annually to the benefitted commercial properties within the District, in proportion to the assessed valuation, frontage, square footage, or another fair and equitable formula as determined by the Town Board.

# **Section 4: Public Hearing**

Pursuant to Section 193 of the New York Town Law, a public hearing shall be held on [insert date] at [insert time and location], at which time all interested parties shall have the opportunity to be heard regarding the establishment of the District.

#### **Section 5: Notice**

The Town Clerk is hereby directed to publish and post notice of the public hearing in accordance with applicable provisions of Town Law.

#### **Section 6: Effective Date**

This resolution shall take effect immediately, subject to the holding of the required public hearing and final approval by the Town Board.

# Article from the Daily Sentinel dated June 6, 2025 with residents comments

NEW HARTFORD — The New Hartford Town Board heard a presentation from a developer hoping to build a storage unit facility on Kellogg Road at a Wednesday, June 4 meeting, along with the concerns of residents who live in the area near the proposed project.

Steve Buck of Buck Construction appeared before the town board to present his plans for a self-storage facility at 39 Kellogg Road. This project had been discussed at four previous meetings, where board members discussed stormwater mitigation, traffic safety and aesthetics, but this was the first meeting where residents turned out to voice their opposition to the proposed development.

Buck is seeking the approval of a planned development district, which would be the first step in allowing him to construct the facility. If the board gives approval — which it has yet to do — the project would

then move forward to the planning board for site plan review, and would then go back to the town board for final approval.

Buck brought his hired engineer to the meeting to address the stormwater component, and proposed that the exterior of the units have a residential design. During Buck's presentation, attendees made their disapproval of the project clear, asking questions about traffic safety, stormwater, aesthetics and safety. Residents expressed concerns about the fact that the access road to the units would be located on Kellogg Road, a busy thoroughfare that has traffic safety issues.

"Right where that entrance is, is where that road suddenly narrows from multiple lanes down to just two, and you're going to have people turning in there, coming out of there, you're going to have a lot of accidents," an attendee said. "There's a traffic light down there that backs everybody up, the Dunkin Donuts backs everybody up down the road, and the gas station with the lowest gas prices in the county that everybody's trying to get in and out of for their gas."

Buck said that self-storage facilities generate the lowest traffic out of any commercial business. He also asked if it would be better if he moved the access road.

Another attendee who has lived in the Oxford Town Apartments for over 50 years spoke about the stormwater and flooding issues.

"If you look behind my house, or any of the houses, there is a river that comes because we get all the drainage from Woodberry, Beechwood, and it's down there all the time," the attendee said. "It has eroded the backyards of our homes. If you look it the area bordering Route 8, it is wetland, wetland, wetland, and all you're going to do now is take up a small radio station that hasn't been there for years, and you're going to put a large piece of property that is going to be a nonpermeable for all of the rain, snow, and it's going to be more of a disaster than what it is now."

Buck asked if it would be acceptable if he were to reduce the amount of stormwater coming off of the parcel, and the attendee said that he could move the project to a different location. "We're not here to propose a project that would piss off the neighbors," Buck said. "But can you imagine if somebody put a titty bar there at a commercial distance, a gentleman's club?"

He explained that when mitigating stormwater for such projects, developers have to design and build stormwater retention measures on the property that capture the runoff and release it into the drainage area at a slower rate.

As residents continued to question Buck, Town Supervisor Paul Miscione said that many of these questions would be answered if the project were to progress to the planning board, but the town board would not be taking any action that night. Buck will have the opportunity to return at a future meeting, where he can address the questions and the town board will take a vote.

The town board also passed a local law to impose a 5% hotel occupancy tax in the town.
