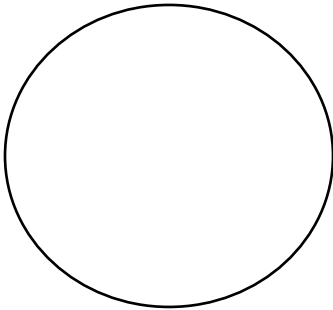

FOOD TRUCKS

Each Food Truck must submit an application completed in full and signed in the presence of a Notary Public. **Application Fee is \$25.00 PER TRUCK (THERE IS NO APPLICATION FEE FOR FARMERS MARKET ONLY).**

The Peddler Identification Card is enclosed for the Signature of each Peddler. **Please have them sign the card;** we will complete the rest of the information. Please return the card with an **Original Signature** for further processing. Also please print their names & the name of the Food Truck in the lower left-hand corner of each page.

Each person must provide the following:

- * Certificate from the Oneida County Health Department
- * Legible photo copy of their Valid Driver's (showing a street address)
- * Proof of Business Insurance naming the Town of New Hartford as an additional insured
- * Proof of Vehicle Insurance on the Mobile Vending Unit or vehicle pulling the unit that will be used for the sale of goods.
- * Each Peddler submitting an application should also submit (2) two passport size photos of themselves and a legible photo copy of their valid driver's license.

A SIX-MONTH LICENSE IS \$125.00 - NON-REFUNDABLE

A ONE YEAR LICENSE IS \$200.00 - NON-REFUNDABLE
