A Local Law to amend the Code of the Town of New Hartford, Chapter 107A, Section 107A-3: entitled STANDARDS FOR OPERATION AND PLACEMENT ON ROTATION LIST; APPLICATION

BE IT ENACTED by the Town Board of the Town of New Hartford, Oneida County, State of New York as follows:

Section 1. Chapter 107A of the Code of the Town of New Hartford, is hereby amended: to add 107A-3 A (11) as follows:

Any person removing a wrecked or damaged vehicle from a highway shall retrieve any glass or other injurious substance dropped upon the highway from such vehicle. Where no environmental hazard exists, the tow service is responsible to mitigate, absorb and retrieve fluid to include washer fluid, antifreeze, coolant, brake fluid and engine oil.

Section 2. All other provisions of Chapter 107A of the Code of the Town of New Hartford, and amendments thereto, are hereby affirmed except to the extent that this Local Law shall modify or amend.

Section 3. This Local Law shall become effective immediately upon its filing with the Office of the Secretary of State.

Town of New Hartford, New York

A Local law to amend the Code of the Town of New Hartford, Chapter 88; Section 88-10.2; entitled FISHING

BE IT ENACTED by the Town Board of the Town of New Hartford, Oneida County, State of New York as follows:

Section 1. Chapter 88 of the Code of the Town of New Hartford, Section 88-10.2 is hereby amended as follows:

§ 88-10.2 Fishing, Hunting, Trapping

All persons are prohibited from fishing at the Washington Mills Athletic Park from the Friday immediately preceding the first Saturday in June, beginning at 12:00 noon on that Friday, until 2:00 p.m. on the first Saturday in June. The only fishing allowed would be during the fishing derby by those participating with children under the age of 16 from 9:00 a.m. until 2:00 p.m. on the first Saturday in June.

All persons are PROHIBITED from Hunting or trapping at the lands owned by or under the control of the Town of New Hartford including the “Donovan Memorial Park”, “Sherrillbrook Parks”, “Washington Mills Athletic Park”, “Veteran’s Memorial Park” and “Philip A. Rayhill Memorial Trail” and that “posted” signs be placed at each park informing the Public.

Section 2. All other provisions of Chapter 88 of the Code of the Town of New Hartford, and amendments thereto are hereby affirmed except to the extent that this Local Law shall modify or amend.

Section 3. This Local Law shall become effective immediately upon its filing with the Office of the Secretary of State.

- B. **Narla Lane** – Joe Lapaglia – there was a temporary easement when Narla Lane was approved for a turnaround – it was to exist until the connection was made with Tilden Avenue, which never happened – the problem is, we have the turnaround – it is between Lapaglia’s property and another residents property – it has worked for a number of years until this past year, Mr. Lapaglia neighbor has put in blockage including debris so that the only portion that can be used is the portion on Mr. Lapaglia property which he continues
