I. <u>ADDRESS SIGN – Incident in the Town</u>

NEW HARTFORD — The town of New Hartford is looking into amending its town code to make it easier to address signs that create a nuisance.

The town board met for a special meeting on Friday, Nov. 1, to discuss an ongoing issue within the town about nuisance signs that have been placed in the town, the implications of allowing such signs, and what can be done about them.

This issue began in October, when signs mounted on trucks were placed on land bordering a house on Sylvan Way, displaying a vulgar message and targeting a town official.

Police Chief Ronald Fontaine said there is an ongoing investigation into some of the conduct that took place on Sylvan Way. He said that the police department, along with the town offices, have been receiving calls from other residents of Sylvan Way who were disturbed by the signs. Earlier this week, the owner brought the sign that targeted the town official down to the parking lot of the town municipal building at 8635 Clinton St. It has since been removed.

"It looked terrible. It was terrible to have it here, especially during the voting, with members of the public coming here to use the facility. I voted here myself the other night," Fontaine said. "I think if we don't get

ahead of this and get some sort of law in effect to properly deal with these situations, it could continue or anyone could come and put any sign up. It's this sign right now, and next time it's a different sign for a different reason or attacking a different person."

Fontaine said that allowing this could open the floodgates for other people to place signs in the town's parking lot, like to advertise a business.

Town Attorney Herb Cully said that there have been two code violations regarding the signs over at Sylvan Way, as the town ordinance prohibits signs on trailers, and it prohibits signs of that size and material. A permit is also required.

Miscione said he spoke with the individual who placed the signs. He said that the individual was also loudly playing music.

"I told him, 'Listen, the other neighbors that are there, it's not their fight. It's like being in a war and innocent people get killed. It has nothing to do with the other people, and they're the ones getting inconvenienced," Miscione said.

"There's gotta be a way that we can control things in neighborhoods where everyone is being affected," he added.

Cully said these issues have been ongoing since August. He said that under the current ordinance, the town sends out a notice of violation, giving a deadline for the violation to be corrected and a fine. Cully said the individual who placed the sign was willing to pay the fine and keep the sign up. He said in a situation where the sign is on public property, the town's police powers give it the right to take action. The councilors agreed that an individual should still have due process and receive the notice of violation, but if they do not remove the sign, the fines should increase and the town should be permitted to take action and remove the nuisance sign.

Cully said he can draft a local law with these provisions. The language of the law would have to specify that it is regarding signs that are meant to harass and have no legitimate purpose, he said.

"This is about people who are antagonizing the area," Miscione said. "That's all they're doing, there's no value to it."
