NEW HARTFORD — At a Wednesday, April 9 meeting, the New Hartford Town Board denied a special use permit application for a solar project at 9444 Roberts Road.

Solar Liberty had proposed a seven-megawatt solar project at 9444 Roberts Road, encompassing 21 acres of land. Representatives from the company had attended a March 12 town board meeting, seeking a special use permit for the project, which would allow it to move on to the town's planning board for the site plan review process.

At the meeting the representatives presented plans for the project, where they said they would work with the town to create a landscaping plan that would shield the system from view, and took questions from concerned residents.

The town had sent letters to residents who live in the area surrounding the location of the proposed solar project, and many of those residents attended the meeting, asking questions about the safety of the project, how it will impact their home values and lives, and expressed concerns about the visibility of the panels.

At the March meeting, the board tabled the proposal until April 9 so Solar Liberty could prepare additional materials. Town Attorney Herbert Cully read email correspondences between legal representation for Solar Liberty and the town about the adjournment request, where the lawyer for Solar Liberty said that if the board denied the request and voted to reject the application, the company would be continuing in its lawsuit that it filed against the town in January.

In its lawsuit, Solar Liberty is seeking an order from a judge directing the town board to approve the special use permit application and refer the project to the planning board. Solar Liberty had first presented the project to the town board in June 2024, and the board tabled the project to gather more information. Solar Liberty then filed the lawsuit after the town board did not take any further action on the proposal, and the town agreed to hear the proposal again in March 2025.

The developers were not present at the April 9 meeting, but the board decided not to honor the request and denied the application.

"I had my suspicions that it was just an attempt to build a better record litigation and there was really no interest in giving the application any real consideration, but my client was hopeful and interested in attempting to resolve this matter without further litigation, opted to attend the meeting understanding the reservation of rights," the letter from Solar Liberty's lawyer read. "Based on how my client was treated at last month's meeting and the anticipated denial this evening of a simple routine adjustment request, it appears that I was right."

Town Supervisor Paul Miscione pointed out that Chapter 118-74 designates two locations in the town—town-owned property on Route 12B and on Middle Settlement Road, from Commercial Drive to Clinton Road—as applicable places for large-scale solar energy systems. The law also states that no free-standing or ground-mounted systems will be permitted in residential districts.

"That's why we're here tonight as a board before it goes to the planning board, to make a determination if it is going to hurt the characteristics of the neighborhood," Miscione said.

Cully said that under the town's solar law, the town board is required to consider how neighbors would be impacted by the installation of a solar project near their properties.

He said the basis for the denial include: a close proximity to residential neighborhoods, inability to screen, proximity and visibility from New York State Route 8 and potential for distraction or glare, the visual impacts.

The board also set public hearings for three proposed local laws that are meant to ensure that the town's fiscal burden does not fall solely on its taxpaying residents. On Wednesday, June 4, the town board will hold public hearings for laws to institute a hotel occupancy tax, to set up a special assessment district for police protection services in commercial areas, and to require Airbnb and other short-term rental units to be registered and have fire inspections.

WHEREAS, the Town Board of the Town of New Hartford has received an application from Solar Liberty Energy Systems, Inc. (Solar Liberty) for the installation of a LARGE-SCALE SOLAR ENERGY SYSTEM at 9444 Roberts Road in the Town of New Hartford and

WHEREAS, Solar Liberty made an initial presentation to the Town Board on June 5, 2024 at which time then application was" tabled" and

WHEREAS, Solar Liberty has made subsequent presentations to the Town Board on February 12, 2025, March 12, 2025 and April 9, 2025 and

WHEREAS, Town Code Chapter 118-74, Section 1 (A) Purpose requires that the Town Board "balance the potential impact on neighbors when solar collectors may be installed near their property" and

WHEREAS, 118-74 (D) (2) states that such LARGE-SCALE SOLAR ENERGY SYSTEMS "shall be permitted in those districts which are designated by the Town of New Hartford Town Board. The Town of New Hartford designates the Town property on Middlesettlement Road from Commercial Drive to Clinton Road and Town owned lands adjacent to Sherrill Brook Park, Rt. 12 as locations for LARGE SCALE SOLARS" and

WHEREAS, the Town Board has received comments from residents on Roberts Road, Oneida Street, Mallory Road and Sessions Road as well as other nearby residential area in the Town and given full consideration to the presentation and comments, it is

RESOLVED, that the application of SOLAR LIBERTY is DENIED and not referred to the Planning Board based upon the following findings:

- (a) Close proximately to residential neighborhood
- (b) Inability to screen
- (c) Proximity and visibility from New York State Route 8 and potential hazards from glare or distraction
- (d) Visual impacts
- (e) The following findings below:

The Town Board of New Hartford has denied the proposed solar project on Chapman Road in a residential neighborhood. This decision was based on several key considerations:

- 1. Zoning Restrictions: According to the Town of New Hartford's Zoning Code, specifically § 118-74, freestanding or ground-mounted solar energy systems are not permitted in residential districts. The code states that such systems "shall not be permitted in residential districts."
- 2. Public Feedback: The Board received significant negative feedback from residents regarding the proposed project. Community members expressed concerns about the project's impact on the character of their neighborhood and potential property value implications.
- 3. Adherence to Approval Processes: The proposal did not align with the town's established approval processes for such projects. As outlined in the Zoning Code, all planned development district applications require adherence to specific provisions, and any development must obtain all relevant permits or approvals before commencement.

Given these factors, the Town Board determined that approving the solar project would be inconsistent with existing zoning regulations and community interests, leading to the denial of the application.

Discussion: COUNCILMAN TEHAN – doesn't believe BAN was funded or purchased yet (Supervisor Miscione stated it will be next week) Councilman Tehan asked this get tabled until the BAN is funded (Highway Superintendent stated we cannot as we would have to go back out to BID and start over and none of the roads would get done until October/November. Since the BAN is not funded yet (Supervisor Miscione said there is \$2 million in the budget (2025 BAN) for paving). Councilman Tehan – what makes today the day we have to approve, we can do another meeting; Town Attorney Herbert Cully - The BID stated April 7, 2025 was the day we were opening the BIDS and would be awarded (done all the time); Supervisor Miscione – we are not paying for it yet, we are just awarding it, we will later sign a contract (subject to a contract); Supervisor Miscione – this is pretty simple, we have a BID, it come in, we approve the BID with the best price, if you want borrow from FUND Balance and then pay it back when the BAN comes in, to make you feel comfortable, that's fine BUT we have BID, we went out to BID, we should never have never gone out to BID and the BOARD approved the BID to go out to BID, it should never have gone out if the Board feels different now; Councilman Tehan – this Board did not approve for anything to go out to BID; Supervisor Miscione - yes we did, including Councilman Tehan - we have to go out to BID; Supervisor Miscione – there is no way the BAN will not go through, Adirondack Bank, locally, even said they would do the BAN, we are going out to BID to get the best rate. If you all feel comfortable, we can borrow it from FUND balance and pay it back; Councilman Tehan – I feel comfortable if we made it subject to the BAN being paid Supervisor Miscione – we have a BID and we have to vote on what is going on (Town Attorney - have to award it or don't and if not go back out to BID) we award it or we don't, you can say NAY if you want, that is fine, the only thing we can do is again, borrow it from FUND balance and pay it back once we have the BAN and if that make everyone else feel comfortable, that is fine; Councilman Messa – let's just do that; Town Attorney Herbert Cully – why would we wait and see – it is two months now, they wait to be paid, do the work and get paid – we went out for BID, we award the BID now; Supervisor Miscione – we are wasting time, it doesn't matter what you say, it is still going to happen the same way – if you say we are going to take it out of FUND balance, guess what is going to happen, the BAN is going to come in, I am going to pay it from the BAN anyway, so it is just to make everyone feel comfortable (can we just get it done). We ALL approved for the BID, we ALL approved for the BAN, we have all approved everything so far, why stop now; Councilman Tehan – only because the BAN is not in; Supervisor Miscione – it doesn't matter, it's a technicality that makes someone feel better - tell me how the BAN is not going to come in Dave? If you can legitimately give me an educated answer of why it is not going to come in, then I am on your side. I just can't understand it. Please, someone come up with why the BAN would not come in. I want to understand WHY we are even talking about this again, why? Why would the BAN not come in or are we just causing another issue? I want an answer why the BAN would not come in; Councilman Tehan – the money is not here; Supervisor Miscione – why would the BAN not come in Dave?; Councilman Tehan – tell everyone about the Town's ratings, tell everyone about the Town's rating being withdrawn; Supervisor Miscione – well its withdrawn because we don't have the 2023 audit; Councilman Tehan – what are we on? Credit Watch; Councilman Latini – let's vote, Rick knows what he is doing, lets move on; Town Clerk Cheryl Jassak-Huther – let's vote (milling) can we go down the line and vote – vote was made for milling (vote 3 to 2); Councilman Tehan – spoke to Councilman Latini stating he needs to understand this because he is a part of this – so I am going to read it to you so you can understand it and I

WANT this part of the minutes, this is the notice for the Bond, this is what goes out to investors – Tehan read: "On March 3, 2025, S&P Global Ratings placed its long-term and underlying rating of the Town of New Hartford on CreditWatch with negative implications. The ratings were placed on CreditWatch because S&P has yet to receive fiscal 2023 financial statements from the Town. S&P considers the financial statements necessary to maintain and assess the ratings on the Town. On April 4, 2025, S&P Global Ratings withdrew its "AA- "issuer credit rating of the Town. The withdrawal reflected S&P's inability to obtain adequate and timely financial information necessary to maintain surveillance of the ratings in accordance with their applicable criteria and policies. Such financial information includes 2023 audited financial statements."

Tehan - 2023 Audit has not been started because the RECS have not been done and it's all part of the years of recons not being done; Supervisor Miscione – no that is not true, how did we do the 2022 then?; Councilman Tehan – because Drescher Malecki did the recon through the end and said put it in the system; Supervisor Miscione – exactly and had no problem doing it and then we go together with everything else and slowed down the process and Drescher Malecki stopped because Councilman Tehan had a meeting with them and said there were issues – Erika said she stopped them when thought they were already going; Councilman Tehan – why would she listen to me; Supervisor Miscione – believe Councilman Messa was in the meeting as well; Councilman Tehan – they are not doing recons, the Town is (Supervisor Miscione – just like in 2022) (Christina – they have actually started the 2023 audit, Councilman Tehan stated ah, that is not true, so I am not sure who is telling you that, that is not true); How do you know that - Supervisor Miscione – thought reconciliations were done for 2023; Councilman Tehan – asked, are they done, have they all been done for 2023 – have they all been updated?; Christina – not all of them but just a couple she is still working on; Councilman Tehan – again, you should understand this rating; Supervisor Miscione – I understand the rating, I am the one who got it where it is; Councilman Tehan – I am talking to JOHN; Supervisor Miscione – once we get our 2023, the rating has to get redone; Councilman Tehan – here is the implication guys, the BAN goes out, the purchasers says, there is more risk to this purchase, I need a higher interest rate, ok, that is the implication, next year, when we have to BOND (Supervisor Miscione – we are not BONDING next year, we are going to BAN again) - you are going to keep rolling the BAN? (Supervisor Miscione - you are going to have to) - I don't agree, it doesn't make sense, how are you going to keep rolling the BAN (Supervisor – you can roll the BAN for three (3) years) - Councilman Tehan - I don't support that and I will say that now and we can talk about it next year but the implications is higher rates; Highway Superintendent Richard Sherman – In 16 years I have never had a problem awarding a paving BID; Supervisor Miscione – I have never had a problem with my BOND rating either. I have an issue too, we are spending \$4,500 for Bonadio and we finally got January's reconciliations so they didn't even do Feb and March – talking about NOW – they still don't have things done in a monthly fashion – that is slowing the process down, that is why we don't have our audit (Councilman Tehan – that has nothing to do with 2023). It all has to do with 2023, it would have been done quicker if we didn't slow the process down. We have been doing it that way the same way every year and now we have a problem. We changed the system. If that is the case Councilman Tehan and you knew all about this, then you voted to go out for this BAN, then you knew we didn't have the 2023 audit complete, so why did you vote for that Dave? That is my question (Councilman Latini – he said Councilman Tehan didn't remember doing it). You (Councilman Tehan) don't remember voting for the BAN?; Councilman Tehan – I remember voting for the BAN; Supervisor Miscione – so why did you vote for the BAN when you knew we didn't have the 2023 audit and you said you knew, you just said it; Councilman Tehan – because you had indicated it was going to be done in the early part of 2025 but here we are and the 2023 audit is not even started; Supervisor Miscione – this is not true because we didn't even approve Drescher Malecki until January, we approved the BAN before we approved Drescher Malecki to do the 2023. We were going to have Bonadio do it and they gave is an outrageous price; Councilman Messa – we didn't approve Drescher Malecki for the recons; Supervisor Miscione – again, we approved the BAN knowing the audit wasn't done, ALL OF US. We BONDED in

2022, that is how we got the rating, best interest rate, was even stated in the Observer Dispatch. This all started because of the 2023's, this was not before every year. This was rated in 2022 when we bonded and we were all caught up with our audits; Christina Lacy – isn't Bonadio doing 2024?; Councilman Tehan – they are doing recons not the financial statement audit; Christina Lacy - if they are keeping up then it should be easy for Erika do to the audit; Councilman Tehan – she has to finish 2023 before 2024 can start and it hasn't happened so 2024 is not even a discussion yet; Supervisor Miscione – so they (Bonadio) didn't even start 2024 recs)?; Councilman Tehan – Bonadio is waiting for year end 2023 to balance; Supervisor Miscione – so they didn't even start? When they were here they said they were going to start and have those done; Councilman Tehan – Bonadio was under the expectation that 2023 was going to be done (Supervisor – that is not what he said when he came to the meeting and we gave them a contract for \$60,000); Councilman Latini – so what do we have to do, approve the paving?; Councilman Reynolds – yes I want to get the paving done, if we have to take out of the FUND balance and move it after the BAN, then that is what we have to do, paving is critical, we can't keep putting it off or waiting until Oct/Nov. to do the paving, it is not going to work; Councilman Tehan – So Councilman Reynolds, let me ask you this, if by chance, slim or otherwise, the BAN didn't get funded, you are comfortable taking \$2 million out of FUND balance because you want to vote tonight for paving?; Councilman Latini – let me ask you...; Councilman Tehan – Let him answer the question; Councilman Reynolds – YES. Paving has got to get done, that is the way it is; Councilman Tehan – the paving expectation was based on the BAN funding, you are ok without \$6 million in different projects that were earmarked; Councilman Latini – Councilman Tehan are you trying to talk Councilman Reynolds out of it?; Supervisor Miscione – I don't understand, you are trying to tell me the BAN is not going to get funded; Councilman Tehan – I don't know the answer to that; Councilman Latini – then if you don't know the answer to that, then don't comment on it (Supervisor Miscione - exactly); Councilman Tehan said - Councilman Latini I don't think you understand (Supervisor Miscione – oh we understand). John, go ahead and explain it; Councilman Latini – you are worried about the credibility of the Town because the 2023s are not done, that is the only issue but once they are done, we are going to be fine unless they find a tremendous number of bad issues or something. Let's just look at something positive, let's just get the blacktop and paying done. We all voted on it; Councilman Reynolds – Paying is a critical infrastructure and it has got to be done. I think we have identified some very serious issues with paving. You have roads with grass growing through the blacktop; Supervisor Miscione – if worse comes to worse and the BAN doesn't come through, I will personally write the Town a check for the 3%, how's that? I'm serious, I will write the check for 3%, done.

The whole philosophy is that if you have a seven (7) person Board, the person who is applying should be entitled to have all seven (7) to vote because he still needs four (4) affirmative votes whether you have five (5) or six (6) there and what Herb has done in the past and always done on any Board have appeared in front of, when they don't have a full Board, they give you an opportunity to come back when they do have it or put in an alternate; Supervisor Miscione – yes, that is ok; Town Attorney Herbert Cully – well no, Councilman Tehan disagrees; Councilman Messa – I wasn't at this meeting but Herb, you ask at every meeting when there is not a full Board, you always ask an alternate would you like to come back since we will not have a full Board, did you ask that applicant (before the presentation); Town Attorney Herbert Cully – I don't remember – you have to have a full vote; Councilman Messa – you don't know if someone is going to abstain; Town Attorney Herbert Cully – we know because its Juluis and he is not going to be able to vote – they can't approve because they don't have enough votes; Councilman Reynolds –

based on the agenda, if a Board member looks at the agenda and sees that it is going to involve, lets say National Grid, something you have a conflict with, that should send an alarm bell and he should raise his question to the Chairman – long before the meeting, saying I can't vote on this, I am going to abstain, at that point the alternate should be brought in; Councilman Messa – yes, at that point, prior to the meeting. They need to advise the Chairperson before the meeting; Councilman Reyolds – it is up to us to have an alternate in the mix, right from square one; Councilman Tehan – I don't agree; Supervisor Miscione – that is why we have alternates; Councilman Tehan – I am saying if you have seven (7) butts in seats, you have a full Board. Every applicant that comes in with the same advantage or disadvantage, it's a crap shoot, of who is on the Board. If we are talking about Adirondack Bank, sorry Adirondack Bank, I am going to abstain. If we are talking about Community Partners, Jim is going to abstain. That is a crap shoot of who is on the Board; Town Attorney Herbert Cully – this is a Planning Board where you established an alternate and the Town Law (which I provided to everybody), says that when a person has a conflict an alternate can be called in to vote; Councilman Tehan – NO, the Town Law as you stated – A Town Board may by Local Law or Ordinance (which we did not do), by Local Law or Ordinance, establish alternate Planning Board Member positions for purposes of substituting a member if a member is unable to participate because of a conflict. We don't have a Local Law or Ordinance that allows for that; Supervisor Miscione – we have one for Planning not Town; Councilman Tehan – we have a Local Law in our Ordinance that states Purpose. The Town Board finds that best interest of the Town to appoint alternate members of the Planning Board due to difficulties in paneling a full Board for these reasons – it has nothing to do with it's a conflict and I can't vote; Town Attorney Herbert Cully - wait a minute, we did it by a Local Law; Councilman Tehan – if Julius can't vote you get an alternate in there; Town Attorney Herbert Cully – said he can't vote on this – this is going to be moved because Julius can't be there on Monday so are you ok with Mr. Chiffy being there?; Councilman Tehan – I am ok with an alternate; Town Attorney Herbert Cully – ok we are all set then
