Since then, he has been purchasing the same materials based on Jay-K's quote that the prices were good for forty-five (45) days. Total expenses to date for like materials is about \$18,000. The Town Attorney noted that Town Law, Section 222 requires a Town Board to award contracts for construction, alteration or remodeling of all town buildings to the lowest responsible bidder after advertising for bids that the project exceeds \$35,000. The Town Supervisor said the purchases were piece-meal and under the \$20,000 threshold, and that Park employees performed the labor for bathroom renovations. Upon recommendation of the Town Attorney, the following Resolution was introduced for adoption by Councilman Cittadino and duly seconded by Councilman Woodland:
